_____ **(A.) DISTINGUISHED VISUAL/LITERARY ARTS TEACHER:** This award is for an experienced (5 year min) teacher of the visual or literary arts (includes but not limited to mosaics, sculptures, photography, creative writing, etc.) who has contributed significantly to arts education.

_____ **(B.) DISTINGUISHED PERFORMING ARTS TEACHER:** This award is for an experienced (5 year min) teacher of the performing arts (i.e. music, dance, theater) who has contributed significantly to arts education.
